- Update on the Cotswold District Local Plan Hearings. Cllr Harrison updated the committee. The main points raised were that the land at Faulkners close identified in the SHELAA has reduced from 28 dwellings to 12 single story dwellings; the landowner of land at Milton farm has now stated that the land will not be available in the plan period to 2031; The Inspector has welcomed the statement in the SoCG that CDC are committed to working with FTC to create a successful NDP.
