- **Update on NDP Examiner report.**  
The Examiner recommended that the plan should not proceed to referendum. Subject to confirmation of this by CDC, FTC would need to decide whether to pursue a revised NDP. This would give the SG the opportunity to refine the existing policies and increase the robustness of the plan. It also means that the Local Plan may well be made before the FNP.

FTC hearing statements have been submitted. The Statement of Common Ground between CDC & FTC is in the final stages of preparation.  
Cllr Harrison is meeting with Stow on the Wold prior to the hearing, and will also contact other Town/Parish Councils who have an interest in similar issues.

1. That a new (revised) Neighbourhood Plan should be progressed.
2. The Terms of Reference for the Steering Group are reviewed and revised to allow a change of membership.
3. The Council applies for a new tranche of funding from Locality (it is understood that up to £15k would be available).
4. The Council agrees to (in principle) fund a hydrology report (£5k) and a revised Sustainability Appraisal (£3k) and a contingency (£2k) if the grant application is unsuccessful.
